- 1. More detailed information on each NGO is available with the Secretariat.
- 2. Paragraph 17 of the annex to the Guidelines stipulates that the Board shall establish appropriate procedures for reviewing applications from NGOs for consultative status. To facilitate and accelerate its work, the Board may wish to follow the practice established at previous sessions and request the Bureau of the Board to review the applications of, and information on, the six NGOs annexed to the present document and to submit its recommendations to the Board for consideration at its current session.
