مقدمة

الغرض من قائمة مشاريع التعاون التقني هذه هو تزويد ممثلي الدول الأعضاء، وكذلك الأمانة، بمرجع سهل التناول لاستعماله أثناء المناقشات في دورات مجلس التنمية الصناعية ولجنة البرنامج والميزانية، بل وطوال السنة.

وتبين القائمة أنشطة التعاون التقني في فئات خمس: البرامج المتكاملة، ومشاريع بروتوكول مونتريال، والمشاريع الأخرى التي ووفق عليها في ١٩٩٨ و ١٩٩٩ و ٢٠٠٠ و ٢٠٠١ (خارج نطاق البرامج المتكاملة)، والمشاريع الأخرى التي ووفق عليها قبل عام ١٩٩٨، وسائر المشاريع التي ووفق عليها قبل عام ١٩٩٨ وتوشك على الانتهاء. والمشاريع التي "توشك على الانتهاء" هي تلك التي كان مقدار ما أنجز منها في ٣١ كانون الأول/ديسمبر ٢٠٠١ يتجاوز ٩٠ في المائة من ميزانيتها.

وتقدم هذه الوثيقة بيانات متنوعة، بما في ذلك عنوان المشروع وتاريخ الموافقة عليه وميزانيته وحجم الانجاز. ويمثل الرقم المتعلق بحجم الانجاز مقدار النفقات والالتزامات المتكبدة حتى ٣١ كانون الأول/ديسمبر ٢٠٠١. والرقم الخاص بميزانية كل مشروع يبين مجموع المخصصات الفعلية المتاحة للبرنامج أو المشروع في ٣١ كانون الأول/ديسمبر ٢٠٠١ لا ميزانيته أثناء السنة المشمولة بالتقرير. وتحت كل فئة، ترد البرامج والمشاريع بلغاتها الأصلية، أي باللغة التي ووفق بها عليها من جانب الحكومة المعنية واليونيدو، تحت اسم البلد/المنطقة/الاقليم المستفيد.

وباستثناء الباب الأول الخاص بقوائم البرامج، تصنف المشاريع حسب أرقامها ضمن كل بلد. وتتضمن الوثيقة أيضا قوائم بالمشاريع الاقليمية والعالمية والأقليمية. فالمشاريع المتعددة التمويل، حيث توجد مصادر تمويل مختلفة للمشروع ذاته، ترد مع أرقام المشاريع المتعددة المكونة منها وعنوان كل مشروع والمقدار الاجمالي لمختلف مصادر التمويل. أما في حالة المشاريع الجامعة - مثل المشاريع التي يغطي فيها التمويل المقدم من الجهات المانحة مشاريع شتى - فيقتصر على ذكر المشاريع المنفردة. وتصنف سائر المشاريع التي ووفق عليها في ١٩٩٨ و ١٩٩٩ و ٢٠٠٠ و ٢٠٠١ ومشاريع بروتوكول مونتريال حسب حالة المشروع، أي تبعاً لما إذا كان منجزاً أو ووفق عليه في عام ٢٠٠١ أو جارياً في ٣١ كانون الأول/ديسمبر ٢٠٠١. أما قائمة المشاريع التي ووفق عليها قبل عام ١٩٩٨ فتبين المشاريع الجارية في ٣١ كانون الأول/ديسمبر ٢٠٠١، والمشاريع المنجزة في عام ٢٠٠١.

导言

本技术合作活动一览表的目的是为了向成员国代表以及秘书处提供一份方便的参考材料，不仅可在工业发展理事会和方案预算委员会的届会讨论期间使用，而且可以在全年使用。

本一览表列出的技术合作活动共为五类：综合性方案、蒙特利尔议定书项目、1998年、1999年、2000年和2001年核准的其他项目（综合方案范围以外的）、1998年以前核准的其他项目和1998年以前核准的接近完成的项目。“接近完成”项目系指在2001年12月31日的执行率达到预算90%以上的项目。

本文件提供了各种项目数据，包括标题、核准日期、预算和执行情况。执行数字为到2001年12月31日为止的所有开支和承诺额。每项预算数字反映的是该方案或项目在2001年12月31日可获得的实际拨款总额而不是报告年度期间的预算。各类中的方案和项目系在受援国/地区/领土项下以有关政府和工发组织批准的原来的语文列出。

除第一节方案列表外，其余项目均系在各国内的项目编号排列。本文件还包括区域、全球和区域间项目一览表。对于同一项目有几种资金的多边项目，则附有各自的多边项目编号、项目标题及各种资金来源的总额；至于揽子项目，例如捐助国资助涉及各种项目的那些项目，则只列出单独的项目。1998、1999年、2000年和2001年核准的其他项目以及蒙特利尔议定书项目按项目状况分类，所以，项目是按是否于2001年完成或核准或到2001年12月31日止尚在执行中分组的。1998年以前核准的项目一览表表示至2001年12月31日止还在执行的项目和2001年已完成的项目。

INTRODUCTION

The purpose of the present list of technical cooperation activities is to provide representatives of Member States, as well as the Secretariat, with a convenient reference not only for use during discussions at the sessions of the Industrial Development Board and Programme and Budget Committee, but throughout the year.

The list shows technical cooperation activities in five categories: integrated programmes, Montreal Protocol projects, other projects approved in 1998, 1999, 2000 and 2001 (outside the integrated programmes), other projects approved before 1998, and other projects approved before 1998 that are nearing completion. Projects “nearing completion” are those where the delivery level had reached more than 90 per cent of the budget on 31 December 2001.

This document provides various data, including title, approval date, budget and delivery. The delivery figure represents expenditure and commitments incurred through 31 December 2001. Each budget figure reflects the actual total allocation available as of 31 December 2001 for the programme or project, rather than the budget during the reporting year. Under each category, programmes and projects are listed in their original language, as approved by the Government involved and UNIDO, under the recipient country/area/territory.

Except for the first section of programme listings, projects are sorted according to their project number within each country. The document also includes listings of regional, global and interregional projects. Multifund projects, where various funding sources exist for the same project, are listed with their respective multiple project numbers, the project title and the total amounts of various funding sources. For umbrella projects—for example those where donor financing covers various projects—only the individual projects are listed. Other projects approved in 1998, 1999, 2000 and 2001 and Montreal Protocol projects are broken down by project status, thus grouping projects according to whether they were completed or approved in 2001, or were ongoing as of 31 December 2001. The list of projects approved before 1998 shows projects ongoing as of 31 December 2001 and projects completed in 2001.

INTRODUCTION

La présente liste d'activités de coopération technique a été établie pour que les représentants des États Membres, ainsi que le Secrétariat, puissent disposer d'un document de référence commode, utilisable aussi bien lors des débats du Conseil du développement industriel et du Comité des programmes et des budgets que pendant le reste de l'année.

Les activités de coopération technique y sont classées en cinq catégories: programmes intégrés; projets approuvés au titre du Protocole de Montréal; autres projets approuvés en 1998, 1999, 2000 et 2001 (à l'exclusion de ceux relevant des programmes intégrés); projets approuvés avant 1998; et autres projets approuvés avant 1998 mais sur le point de s'achever. Dans cette dernière catégorie entrent les projets dont l'exécution correspondait, au 31 décembre 2001, à plus de 90 % de l'enveloppe budgétaire correspondante.

Le présent document offre divers éléments d'information, notamment le titre de chaque programme ou projet, la date à laquelle il a été approuvé, le budget qui lui est consacré et l'état de son exécution. Le chiffre indiqué pour l'exécution représente les dépenses et engagements de dépenses enregistrés au 31 décembre 2001. Le chiffre indiqué pour le budget correspond au montant total de l'allocation effectivement disponible au 31 décembre 2001 et non au budget pour l'année considérée. Dans chaque catégorie, les titres des programmes et projets sont présentés en langue originale, tels qu'approuvés par le gouvernement concerné et l'ONUDI, et sont classés selon le pays, la zone ou le territoire récipiendaire.

À l'exception des programmes qui sont présentés dans la première section, les projets sont classés par pays et en fonction de leur numéro. On trouvera aussi la liste des projets régionaux, interrégionaux et mondiaux. Pour les projets à financement multiple, c'est-à-dire ceux pour lesquels les sources de financement sont diverses, on trouvera indiqués les numéros multiples respectifs, le titre et le montant total des diverses sources de financement. Lorsque l'on a affaire à un projet composite – par exemple là où les fonds accordés par les bailleurs couvrent plusieurs projets – seuls sont indiqués les projets pris individuellement. Les autres projets approuvés en 1998, 1999, 2000 et 2001 et les projets approuvés au titre du Protocole de Montréal sont ventilés en fonction de leur état d'avancement, c'est-à-dire selon qu'ils ont été achevés ou approuvés en 2001, ou qu'ils étaient en cours d'exécution au 31 décembre 2001. La liste des projets approuvés avant 1998 recense ceux qui étaient toujours en cours d'exécution au 31 décembre 2001 et ceux achevés en 2001.

ВВЕДЕНИЕ

Настоящий перечень проектов технического сотрудничества призван служить для представителей государств-членов, а также сотрудников Секретариата источником справочной информации, который удобно использовать не только в ходе обсуждений на сессиях Совета по промышленному развитию и Комитета по программным и бюджетным вопросам, но и в ходе текущей работы в течение всего года.

Включенные в перечень мероприятия в области технического сотрудничества распределены на пять категорий: комплексные программы, проекты в рамках Монреальского протокола, другие проекты, утвержденные в 1998, 1999, 2000 и 2001 годах (не охваченные комплексными программами), другие проекты, утвержденные до 1998 года, и прочие проекты, утвержденные до 1998 года, которые приближаются к завершению. "Приближающиеся к завершению" проекты представляют собой такие проекты, объем осуществления которых на 31 декабря 2001 года превысил 90-процентный уровень бюджета.

В настоящий документ включены различные данные, в том числе название проекта, дата утверждения, бюджет и показатели осуществления. Показатели осуществления представляют собой данные о произведенных расходах и принятых обязательствах на 31 декабря 2001 года включительно. Данные, касающиеся бюджета каждого проекта, отражают фактическую сумму общих ассигнований, имевшихся в наличии на 31 декабря 2001 года, для осуществления программы или бюджета, а не бюджет за отчетный год. Программы и проекты по каждой категории приведены на языке оригинала в том виде, в котором они были утверждены соответствующим правительством и ЮНИДО по странам/районам/ территориям – получателям.

Исключая первый раздел перечня программ, проекты указываются в порядке, соответствующем их номерам по каждой стране. В настоящем документе также перечислены региональные, глобальные и межрегиональные проекты. В случаях, когда средства на финансирование одного и того же проекта поступают из различных источников, такие проекты, финансируемые из нескольких источников, перечисляются с указанием их всех соответствующих номеров, названий проекта и общей суммы финансирования из различных источников. Что касается комплексных проектов – например, проектов, в рамках которых доноры финансируют различные проекты, – то перечисляются только отдельные проекты. Другие проекты, утвержденные в 1998, 1999, 2000 и 2001 годах, а также проекты в рамках Монреальского протокола приведены в разбивке в зависимости от хода осуществления проекта, и таким образом проекты отнесены к группам проектов, которые были завершены или утверждены в 2001 году, или осуществлялись на 31 декабря 2001 года. В перечень проектов, утвержденных до 1998 года, включены проекты, находившиеся в стадии осуществления на 31 декабря 2001 года, и проекты, завершенные в 2001 году.

INTRODUCCIÓN

La finalidad de la presente lista de actividades de cooperación técnica es proporcionar tanto a los representantes de los Estados Miembros como a la Secretaría una referencia útil y práctica que se podrá consultar no sólo durante los períodos de sesiones de la Junta de Desarrollo Industrial y del Comité de Programa y de Presupuesto sino también a lo largo de todo el año.

En la lista figuran las actividades de cooperación técnica distribuidas en cinco categorías: programas integrados, proyectos relacionados con el Protocolo de Montreal, otros proyectos aprobados en 1998, 1999, 2000 y 2001 (fuera de los programas integrados), otros proyectos aprobados antes de 1998 y otros proyectos aprobados antes de 1998 que están próximos a su terminación. Los proyectos “próximos a su terminación” son aquellos en los que el nivel de ejecución representaba más del 90% del presupuesto respectivo al 31 de diciembre de 2001.

En el documento se suministran diversos datos respecto de cada actividad, comprendidos el título, fecha de aprobación, presupuesto y estado de ejecución. La cifra de ejecución representa los gastos realizados y los compromisos contraídos hasta el 31 de diciembre de 2001. Cada una de las cifras presupuestarias refleja la totalidad de la asignación de créditos efectivamente disponible al 31 de diciembre de 2001 para el respectivo programa o proyecto y no el presupuesto durante el año sobre el cual se informa. Dentro de cada categoría, los programas y proyectos se mencionan en su idioma original, según fueron aprobados por el gobierno respectivo y la ONUDI, bajo el correspondiente país/zona/territorio receptor.

Salvo en la primera sección, donde se enumeran los programas, los proyectos vienen clasificados por el número de proyecto dentro de cada país. El documento contiene también listas de proyectos regionales, mundiales e interregionales. Los proyectos de fondos múltiples, en los que para el mismo proyecto existen diversas fuentes de financiación, se enumeran con su respectivo número dentro de la categoría de proyectos múltiples, junto con el título del proyecto y las sumas totales provenientes de las diversas fuentes de financiación. En el caso de los proyectos marco -por ejemplo, los proyectos en que la financiación de los donantes abarca diversos proyectos- sólo se enumeran los proyectos individuales. Otros proyectos aprobados en 1998, 1999, 2000 y 2001 más los proyectos relacionados con el Protocolo de Montreal se desglosan de acuerdo con la situación del proyecto, o sea, que los proyectos se agrupan de acuerdo con el criterio de que hubieran sido concluidos o aprobados en 2001 o estuvieran en curso de ejecución al 31 de diciembre de 2001. En la lista de proyectos aprobados antes de 1998 figuran los proyectos en ejecución al 31 de diciembre de 2001 y los proyectos finalizados en 2001.
