# **PROPOSALS FOR THE APPOINTMENT OF AN EXTERNAL AUDITOR**

# Candidatures for the appointment of an external auditor

Report by the Director-General

1. On the basis of recommendations by the Programme and Budget Committee and the Industrial Development Board, the General Conference, in its decision GC.5/Dec.17, decided to appoint the President of the Federal Court of Audit of Germany as the External Auditor for UNIDO for a period of two years beginning on 1 July 1994. Subsequently, the General Conference, in its decision GC.6/Dec.18, decided to extend the appointment of the President of the Federal Court of Audit of Germany until 30 June 1998. In that decision, the Director-General was requested, in future, to invite proposals from Member States for the appointment of an External Auditor and to submit such proposals to the Programme and Budget Committee for consideration. At its seventh session, the General Conference decided to extend the appointment of the President of the Federal Court of Audit of Germany until 30 June 2000 (GC.7/Dec.13). Thus, an appointment for an External Auditor is required for the period 1 July 2000 to 30 June 2002.

2. In compliance with decision GC.6/Dec.18, a note verbale dated 22 December 1998 was sent to Member States in which they were invited to inform the Director-General by 15 February 1999 of their interest in

providing the services of an External Auditor, with a view to submitting such proposals to the Programme and Budget Committee at its fifteenth session.

3. In a communication dated 3 February 1999, the Permanent Representative of Germany informed the Director-General of the availability of the current External Auditor for an extension of her mandate as from 1 July 2000.

4. As of 15 February 1999, the following candidatures, including the candidature of the present External Auditor, had been received for the appointment of an external auditor:

Ms. Hedda von Wedel President of the Federal Court of Audit of Germany

Mr. Osei Tutu Prempeh Auditor-General of Ghana

Mr. Manzur Hussain Auditor-General of Pakistan

Mr. D. Ubaldo Nieto de Alba President of the Court of Audit of Spain

5. After the deadline of 15 February 1999, two additional candidatures were received: on 16 February 1999, a communication submitting the candidature of Mr. Lemma Argaw, Auditor General of Ethiopia, was received from the Permanent Mission of Ethiopia to UNIDO; on 1 March 1999 a communication was received from the Permanent Mission of Ukraine to UNIDO, in which the candidature of Mr. Mykola Azarov, Head of the State Tax Administration of Ukraine, was submitted.

6. The communications submitting the respective candidatures appear in the annex to the present document.

7. The full text of financial regulation 11.1 is quoted herewith:

"An External Auditor, who shall be Auditor-General (or an officer exercising an equivalent function) of a

Member State, shall be appointed in the manner and for the period decided by the Conference."

# ACTION REQUIRED OF THE COMMITTEE

8. The Committee may wish to propose to the Industrial Development Board that it recommend to the General Conference the appointment of one of the candidates as External Auditor for UNIDO for a period of two years beginning on 1 July 2000. The appointment would fall under the terms of reference specified in article XI (and annex) of the Financial Regulations of UNIDO. The travel and costs related to the work of the External Auditor are to be borne by the UNIDO regular budget. In the proposals of the Director-General for the 2000-2001 biennium, the budgetary allocation for such travel and costs has been set at \$310,000.
