# Item 2. Report of the Programme and Budget Committee

Article 10.4 (d) of the Constitution requires that the Programme and Budget Committee "report to the Board at each regular session on all activities of the Committee and submit advice or proposals on financial matters to the Board on its own initiative". The report of the Committee on the work of its twentieth session will be reflected in document IDB.29/2. The following subjects and documentation, dealt with by the Committee at that session, are of relevance to the work of the Board at its current session. Annotations are contained in the annotated provisional agenda of the twentieth session of the Committee (PBC.20/1/Add.1). At that session, the Committee recommended to the Board the adoption of a number of draft decisions, as indicated in the report of the session and under the respective subheadings below.

At its twenty-eighth session, the Board considered a report providing information on developments, inter alia, resulting from the closure of the biennial accounts, as well as on the management of technical cooperation projects in both dollars and euros (IDB.28/9). It adopted decision IDB.28/Dec.5, which requested the Director-General to inform Member States of further developments related to the transition to a single-currency system, as well as on the financial management of technical cooperation projects both in dollars and euros.

Furthermore, in compliance with paragraph (b) (v) d of the same decision, the Director-General will indicate a general ceiling for the biennium 2006-2007 based on anticipated resources and on programme activity.

### 3 (c) Decentralization

In its resolution GC.10/Res.2 (7), the General Conference encouraged the Director-General to carry forward the process of decentralization to the field and further strengthen and rationalize the field operations of the Organization, and requested the Director-General to report regularly to the Board on the implementation of that resolution. In its decision IDB.28/Dec.2 (e), the Board invited the Director-General to continue his dialogue with the United Nations Development Programme (and possibly other United Nations agencies), with a view to submitting a proposal for further consideration by the Board or the General Conference.

Subsequently, the informal advisory group on decentralization recommended the consideration of the matter by the Programme and Budget Committee (IDB.29/9-PBC.20/9). In its conclusion 2004/6, the Committee inter alia requested the Director-General to submit to the Board for its information an implementation plan of the strategic alliance with UNDP.

In addition to the recommendation of the informal advisory group (IDB.29/9-PBC.20/9), the Board will have before it:

#### Item 6. Personnel matters

By decision IDB.1/Dec.18 the Board decided to accept the International Civil Service Commission (ICSC) statute. The Board will be informed of recent ICSC decisions and recommendations adopted by the General Assembly that are of relevance to UNIDO, as an organization in the United Nations common system.

By decision GC.1/Dec.37 the General Conference accepted the Regulations of the United Nations Joint Staff Pension Fund and established the UNIDO Staff Pension Committee. In its decision GC.10/Dec.20, the General Conference elected two members and two alternate members of the UNIDO Staff Pension Committee for the biennium 2004-2005. One of the member posts has become vacant upon the departure from Vienna of the incumbent, and the Board may wish to proceed with the election for that post for the remainder of the term in accordance with General Conference decision GC.10/Dec.20, paragraph (c).
