The Government of the Republic of Iraq has undertaken this position out of its honour and respect of the general agreement among the Regional Groups and out of its keenness to maintain the fortunately existing cordial relations with the African States. The Government of the Republic of Iraq would like to stress its right to nominate for future empty posts in the UNIDO and other international Organizations, thus it requests the support of all states of Regional Groups, keeping in mind that Iraq has been deprived for years, due to well known circumstances, of its natural right to assume such posts. In this regard, the Permanent Mission of the Republic of Iraq will highly appreciate it if the President of the Board convey this note to all members of Regional Groups.

The Permanent Mission of the Republic of Iraq in Vienna avails itself of this opportunity to renew to the President of the Board the assurances of its highest consideration.
