Item 8 Implementation of the Cooperation Agreement with UNDP

A representative of the UNIDO Secretariat introduced the item, and statements were made by the representatives of Indonesia (on behalf of G-77 and China), Luxembourg (on behalf of the European Union, the acceding countries Bulgaria and Romania, the candidate countries Croatia and Turkey as well as the countries of the Stabilization and Association Process and potential candidates Albania, Bosnia and Herzegovina, The Former Yugoslav Republic of Macedonia, Serbia and Montenegro and the EFTA country Norway member of the European Economic Area, as well as Ukraine), Nigeria (on behalf of the African Group), Bolivia (on behalf of GRULAC), Pakistan, Japan, Colombia and China.
