Implementation of the Cooperation Agreement with the United Nations Development Programme

Progress report by the Director-General

Reports on the progress made in the implementation of the Cooperation Agreement with UNDP and provides updated and complementary information to the documents submitted to the General Conference at its eleventh session.

I. Introduction

1. At the eleventh session of the General Conference, Member States were provided with updated information on the implementation of the Cooperation Agreement with the United Nations Development Programme (UNDP) contained in documents GC.11/7, GC.11/7/Add.1 and GC.11/CRP.7. The present document provides additional information on the progress made since November 2005.

II. UNIDO Desks

2. Annex I to this document provides an updated overview of the current situation with regard to the operational status of the UNIDO Desks. Since the last reporting period the Secretariat is pleased to inform that the Head of UNIDO Operations in Zimbabwe has taken up his duties and the UNIDO Desk has been operational since January 2006. As a result, a total of 13 UNIDO Desks are currently operational worldwide.

For reasons of economy, this document has been printed in a limited number. Delegates are kindly requested to bring their copies of documents to meetings.



3. As reported in document GC.11/CRP.7, the Secretariat intensified its communication with UNDP New York to bring to its attention a number of issues with regard to the implementation of the Agreement. In this context, the Director-General invited the Deputy Director of the Bureau for Resources and Strategic Partnerships at UNDP for a visit to UNIDO. During the meetings thus held on 26 January 2006, which included special focus meetings with the UNIDO Regional Bureaux, the Director-General expressed his continued commitment to the implementation of the Agreement. He reiterated his intentions to review both the Agreement itself and the already existing UNIDO Desks within the Task Force on Field Operations he had established. The Task Force aimed, *inter alia*, to review and adjust the current field structure of UNIDO.

4. The Director-General also stated during the meeting that he would like to obtain an equally clear and firm commitment from UNDP on the continued implementation of the Agreement.

5. To that end, the Director-General undertook a mission to UNDP New York in mid-March 2006 to meet with the UNDP Administrator and other relevant staff, including representatives of the Regional Bureaux. During these meetings the UNDP Administrator, Mr. Kermal Derviš, confirmed UNDP's commitment and underlined the importance of a better coordination of the United Nations organizations at the field level, particularly within the context of the system-wide reform process.

6. At the meeting with the UNDP Regional Bureaux and the Bureau of Resources and Strategic Partnership, it was agreed that both UNIDO and UNDP would further reinforce the cooperation between the two organizations. Agreement was also reached on putting further emphasis on the joint programme development, particularly on Private Sector Development. Moreover, a focal point on administrative matters, including the upcoming joint assessment of the pilot phase of the Agreement, was appointed.

7. These meetings, as well as interim findings of the Task Force on Field Operations, led to the recognition of the need to consolidate the already existing UNIDO Desks and their functions, including their relationships with UNIDO field offices and Headquarters. Within this context, and pending the outcome of the work of the Task Force on Field Operations, the Director-General decided to put a hold on the process of further recruitments and expansion of the planned UNDO Desks. This will allow UNIDO to review its current achievements and also provide room for necessary adjustments if required.

III. Joint Programming—Private Sector Development

8. Further to the information already provided in documents GC.11/7/Add.1 and GC.11/CRP.7 on the progress made with regard to the implementation of the Framework for joint UNIDO/UNDP technical cooperation programmes on private sector development, annex II to the present document provides updated and detailed information. As shown in annex II, joint programme documents have been finalized for Lao People's Democratic Republic, Nicaragua, Nigeria and the United Republic of Tanzania. In addition, joint programme formulation missions were completed before the end of 2005 in Burundi, Ethiopia, Ghana and Rwanda. Furthermore, joint programme formulation has been initiated in Afghanistan, Jordan and Sierra Leone.

9. With a view to complementing the country-level cooperation, UNIDO and UNDP—with financial support from the Netherlands—participated in a range of activities that provide a private sector and entrepreneurship dimension to the second

phase of the World Summit on the Information Society (16 to 18 November 2005, Tunis). In this context, the joint exhibition on information communication technology (ICT) and convening of panels on the impact of ICTs on the performance of small and medium enterprises in order to strengthen the economic and industrial dimension of the Summit, was successfully completed.

IV. Steps ahead

10. In line with its mandate (GC.11/Res.5), UNIDO will undertake an assessment on the outcome of the pilot phase of the Agreement in consultation with Member States at the thirty-second session of the IDB. Therefore, the evaluation of the initiative will be among the next main endeavours to be undertaken by UNIDO, jointly with UNDP.

11. While additional aspects within the work of the Task Force on Field Operations are also being considered in relation to the UNIDO field network, the Secretariat will continue to implement the Cooperation Agreement to ensure that adequate information can be gathered for the forthcoming evaluation. At the implementation level, an increased focus will be placed on the joint programming activities to allow sufficient information to be presented during the deliberations of the Member States with regard to the future of the initiative.

V. Action required by the Board

12. The Board may wish to take note of the present document and the information contained therein.
