# 3 (a) UNIDO participation in major international events

In its resolution GC.9/Res.3, the General Conference stressed the importance of the World

Summit on Sustainable Development (Johannesburg, South Africa, 26 August—4 September 2002) and requested the Director-General to provide a follow-up report to the Board. Subsequently, at its twenty-fifth session the Board adopted decision IDB.25/Dec.8 which, inter alia, urged the Director-General to continue his efforts to enhance UNIDO's profile and to enhance cooperation with all relevant stakeholders, and requested the Director-General to report to its twenty-sixth session.

# 3 (b) Implementation of medium-term programme framework, 2002-2005, including field representation and technology foresight

The General Conference at its ninth session adopted a medium-term programme framework for the period 2002-2005 (GC.9/Res.2), and requested the Director-General to report to the Conference at its tenth session, through the Board, on the implementation of that resolution. #### 3 (c) Global Biotechnology Forum

As Task Manager for Chapter 16 of Agenda 21, and jointly with the Government of Chile, UNIDO is convening a Global Biotechnology Forum at Concepción, Chile, in late 2003. The aim is to review policy, institutional and socio-economic issues that pertain to the development of and access to appropriate biotechnology for sustainable development. The Forum will also consider mechanisms to facilitate technology transfer to the public and private sectors. Information on the event was provided to permanent missions at a briefing on 21 June 2002, and will be summarized in the following document:

# Item 4. Medium-term programme framework, 2004-2007

In accordance with General Conference decision GC.2/Dec.23, and as subsequently modified in decision GC.6/Dec.10, the Director-General is requested to

By decision GC.1/Dec.37 the General Conference accepted the Regulations of the United Nations Joint Staff Pension Fund and established the UNIDO Staff Pension Committee. In its decision GC.9/Dec.19, the Conference elected two members and two alternate members of the UNIDO Staff Pension Committee for the biennium 2002-2003. Both of the member posts have become vacant upon the departure from Vienna of

the incumbents, and the Board may wish to proceed with the election for those posts for the remainder of the term in accordance with Conference decision GC.9/Dec.19, paragraph (c).
