- 5. The External Auditor shall express and sign an opinion on the financial statements of the Organization. The opinion shall include the following basic elements:
- (a) The identification of the financial statements audited:
- (b) A reference to the responsibility of the management of the United Nations Industrial Development Organization and the responsibility of the External Auditor;
- (c) A reference to the audit standards followed;
  - (d) A description of the work performed;
- (e) An expression of opinion on the financial statements as to whether:
  - The financial statements present fairly the financial position as at the end of the period and the results of the operations for the period;
  - The financial statements were prepared in accordance with the stated accounting policies; and
  - The accounting policies were applied on a basis consistent with that of the preceding financial period;

- (f) An expression of opinion on the compliance of transactions with the financial regulations and legislative authority;
  - (g) The date of the opinion;
- (h) The External Auditor's name and position; and
- (i) Should it be necessary, a reference to the report of the External Auditor on the financial statements.

#### DRAFT CONTRACT FOR APPOINTMENT OF THE DIRECTOR-GENERAL

#### THIS CONTRACT is made

between the United Nations Industrial Development Organization (hereinafter called the Organization) for the one part

and Kandeh Kolleh YUMKELLA (hereinafter called the Director-General) for the other part.

#### WHEREAS

The Director-General, upon recommendation of the Board, has been duly appointed by the Conference at its eleventh session held from 28 November to 2 December 2005.

#### IT IS HEREBY AGREED AS FOLLOWS:

#### 1. Term of Office

The Director-General shall be appointed for a period of four years from the eighth day of December two thousand five (2005), or until the Director-General to be appointed at the thirteenth regular session of the General Conference assumes office, whichever is later.

#### 2. Official Duty Station

The official duty station for the Director-General shall be Vienna, Austria.

#### 3. Official Duties

In accordance with Article 11 of the Constitution of the Organization, the Director-General shall be the chief administrative officer of the Organization.

#### 4. Privileges and Immunities

The Director-General shall enjoy all the privileges and immunities in keeping with his office as determined by the Constitution of the Organization, Article 21, and any relevant legal instruments already in force or to be concluded in the future.

#### 5. Staff Regulations

The Director-General shall be subject to the Staff Regulations of the Organization, together with such amendments as may be made thereto, in so far as they are applicable to him.

#### 6. Assessable Salary and Allowances

- (a) The annual gross salary of the Director-General shall be US dollars two hundred and thirty-three thousand and six (233,006), corresponding to an annual net base salary equivalent to US dollars one hundred and fifty-four thousand six hundred and sixty-four (154,664) (dependency rate) or US dollars one hundred and thirty-seven thousand five hundred forty-three (137,543) (single rate) respectively. The gross and net base salary shall be adjusted whenever the General Assembly decides to adjust the gross and net base salary levels of staff in the Professional and higher categories;
- (b) He shall receive post adjustment, allowances and benefits, including social security benefits, for which a staff member in the Professional category of the UNIDO Secretariat would be eligible under the Staff Regulations and Staff Rules of the Organization, provided the purpose of such emolument, allowance or benefit has not already been met by other provisions of the present contract;
- (c) The Director-General shall receive a representation allowance of euros thirty thousand and thirty-three (30,033) per annum, adjusted for the budgeted annual inflation rate, to meet his share of the obligations which the Organization incurs in the form of representation and hospitality expenditure;
- (d) He shall receive a housing allowance amounting to euros forty-seven thousand and seventy (47,070) per annum adjusted for the budgeted annual inflation rate;
- (e) The above salary, allowances and benefits to which the Director-General is entitled under this agreement shall be subject to adjustment by the Board, after consultations with the Director-General, to keep them in line with those of the executive heads of other specialized agencies within the common system of the United Nations.

#### 7. <u>Pension Arrangements</u>

The Director-General shall participate in the United Nations Joint Staff Pension Fund in accordance with the provisions of decision IDB.10/Dec. 17 (d) of the Industrial Development Board. His pensionable remuneration shall be determined and adjusted in accordance with the provisions of articles 54(c) and (b) of the regulations and rules of the United Nations Joint Staff Pension Fund.

#### 8. <u>Currency of payments</u>

Payments will be effected in the currency applicable to staff in the Professional and higher categories serving at the official duty station Vienna, Austria.

#### 9. Notice of Resignation

The Director-General may at any time give three months' notice of resignation in writing to the Board, which is authorized to accept his resignation on behalf of the General Conference, in which case, upon expiration of such period of notice, he shall cease to be Director-General of the Organization and this contract shall terminate.

#### 10. Entry into force

This contract shall enter into force as of the eighth day of December 2005.

#### RESOLUTIONS

## GC.11/Res.1 REGIONAL PROGRAMME FOR LATIN AMERICA AND THE CARIBBEAN

The General Conference,

Taking note of the Millennium Development Goals adopted by the Millennium Summit of the United Nations,

Bearing in mind the 2005 Human Development Report prepared by the United Nations Development Programme, which draws attention to the decreasing share of Latin America and the Caribbean in international trade flows, as well as the limited progress made in increasing average income and reducing poverty in the region,

Taking into account resolution GC.10/Res.8, entitled "Poverty reduction in developing countries, particularly in Latin America and the Caribbean in the context of sustainable development", in which the General Conference, in the year 2003, requested the Director-General to allocate resources to the extent possible to initiatives and programmes in the region, in accordance with the mandate of UNIDO,

Considering decision IDB.30/Dec.8 on the medium-term programme framework, 2006-2009, in which the Director-General was requested to establish a regional programme for Latin America and the Caribbean during the biennium 2006-2007 and to report on it periodically to the Industrial Development Board,

Recalling the Memorandum of Understanding signed in October 2005 between the Director-General of UNIDO and the Secretary-General of the Organization of American States, the purpose of which is to establish a framework for the implementation of joint programmes in all the countries of Latin America and the Caribbean,

Emphasizing the need for UNIDO, on the basis of experience gained in the formulation and implementation of technical cooperation programmes in the various countries of Latin America and the Caribbean, also to attend to the challenges and opportunities affecting sustainable industrial development in the whole region,

1. Requests the Director-General, taking into account the General Conference resolution and the Industrial Development Board decision referred to above, together with document GC.11/12 and the strategic long-term vision statement, to adopt, in

consultation with the Member States of the region, the necessary measures to establish a regional programme for Latin America and the Caribbean before the thirty-first session of the Industrial Development Board, with a view to its implementation in the biennium 2006-2007;

- 2. Requests the Secretariat of UNIDO to identify and mobilize financial resources which, without affecting the resources assigned to other regions, will permit the implementation of the regional programme for Latin America and the Caribbean;
- 3. Further requests the Director-General to inform periodically both the Industrial Development Board, beginning at its next session, and the General Conference on action taken in pursuance of the present resolution.

## GC.11/Res.2 UNIDO ACTIVITIES IN THE PALESTINIAN TERRITORIES

The General Conference,

Fully aware of the severe economic and social conditions under which the Palestinian people are living in the occupied territories,

Conscious of the significance of the economic growth, in particular after the Israeli disengagement from the Gaza Strip, to the generation of job creation for poverty reduction and promotion of peace and stability,

Aware of the role of the development of the industrial sector in the overall economic growth, and the importance of the UNIDO integrated programme in upgrading Palestinian industries,

Noting with satisfaction the findings of the recent UNIDO independent evaluation report for the UNIDO activities during the period 1999-2005, and the achievements reached in the process of industrial development,

- 1. *Expresses* its appreciation to Member States and UNIDO for providing the needed funds to carry out the first phase of the programme;
- 2. *Emphasizes* the need to continue implementing in full the second phase of the programme;

- 3. *Emphasizes* the importance of coordinating such programmes and activities with donors and other relevant development organizations within the United Nations system;
- 4. *Encourages* Member States to contribute funding to the second phase of the programme;
- 5. *Requests* the Director-General to keep Member States informed on the achievements in that regard.

## GC.11/Res.3 UNIDO INITIATIVES IN THE UNITED NATIONS DEVELOP-MENT SYSTEM

The General Conference,

Noting the initiatives of the Director-General of UNIDO in developing proposals to renew the United Nations economic development functions so as to improve the prospect of achieving the Millennium Development Goals in a sustainable manner,

- 1. *Commends* the Director-General for his important contribution and commitment to enhancing economic development activities in the United Nations system for the benefit of developing countries;
- 2. Underlines the desirability of further enhancing and promoting UNIDO's cooperation with other organizations, particularly within the United Nations system, in order to implement the Millennium Declaration and achieve internationally agreed development goals;
  - 3. *Requests* the Director-General:
- (a) To continue to participate actively in the framework of the United Nations Chief Executives Board, High-Level Committee on Programmes, the task force established for that purpose and the United Nations Development Group;
- (b) To continue to identify priority areas for coordinated responses in the field of economic development;
- (c) To strive to fully implement the Triennial Comprehensive Policy Review of operational activities for development of the United Nations system, as set out in General Assembly resolution 59/250, and to report thereon on a regular basis;
- (d) To ensure UNIDO's active participation in relevant meetings of United Nations bodies and

important events, including the UNCTAD XI Mid-Term Review, the comprehensive global review of the implementation of the Brussels Programme of Action for the Least Developed Countries (2001-2010) and the fourteenth Commission on Sustainable Development, and to consult with Member States in the run-up to those conferences on planned UNIDO initiatives and activities.

## GC.11/Res.4 STRATEGIC LONG-TERM VISION STATEMENT

The General Conference,

Recalling General Conference resolution GC.10/Res.2 inviting the Director-General to develop a strategic long-term vision statement in time for its adoption by the next General Conference,

*Taking note* of the information provided in documents GC.11/8 and Add.1,

- 1. *Adopts* the strategic long-term vision statement for UNIDO covering the period 2005-2015, as contained in the annex to the present resolution;
- 2. Requests the Director-General to take the strategic long-term vision statement into account when formulating and implementing the medium-term programme frameworks, the programmes and budgets and other operational programmes during the period under coverage.

#### Annex

#### Strategic long-term vision statement, 2005-2015

#### Introduction

- 1. In the context of the changing global economic environment and emerging needs of developing countries and countries with economies in transition, the United Nations Industrial Development Organization (UNIDO) must profile itself as a competent, effective, efficient and professional organization, contributing to relevant international development objectives and to sustainable industrial development in these countries.
- 2. The international development objectives, in particular the Millennium Development Goals (MDGs), and the developments in the world economy,

especially the complex process of economic globalization and marginalization of poor countries, will together be the major driving forces determining the future scenarios. Added to these are issues related to appropriate technology transfer, foreign direct investment and sustainable use of the environment and natural resources as well as energy, which impact on industrial development.

- 3. The challenges and opportunities to be addressed by UNIDO in the coming decade through the promotion of sustainable industrial development include the following:
  - Poverty alleviation in the context of MDGs as the most important development goal in the next 10 years;
  - Economic globalization, which has potential benefits as well as downside risks, including marginalization;
  - Environment and energy as factors for sustainable development;
  - Sub-Saharan African countries' unique development needs and differentiated development requirements of other regions;
  - Countries and regions emerging from crisis situations resulting from man-made or natural disasters requiring international assistance.
- 4. UNIDO will need to address these challenges on the basis of its mandate, taking into account the Business Plan on the Future Role and Functions of UNIDO, the Strategic Guidelines Towards Improved UNIDO Programme Delivery, and its corporate strategy, using its comparative advantage to ensure value addition within the framework of the United Nations development system.

#### Areas of focus

- 5. In order to deal with the future challenges, the activities of UNIDO will need to focus on the following three areas:
- (A) Poverty alleviation through productive activities

The activities and programmes under this group will focus on the following:

- (a) Entrepreneurship (including rural and women's entrepreneurship) development;
- (b) Small enterprise and business development;

- (c) Development of microenterprises, including informal sector upgrade;
- (d) Development of the domestic private sector;
- (e) Institutional capacity-building at the country and sectoral levels;
- (f) Development of agro-industries and textiles;
- (g) Industrial policy advice based on applied research;
- (h) Assistance in the diffusion and transfer of modern and relevant technologies;
- (i) Assistance in the creation of conducive investment climate;
- (j) Promoting industrial growth in less developed areas with a focus on employment and income generation.

#### (B) Trade capacity-building

The activities and programmes under this area of focus will seek to assist the developing countries and transition economies to build and develop both production and trade-related capacities, including the capacity to conform to the standards of international markets. These will include:

- (a) Assistance in building and developing production and export capacities in quality products and for conforming with technical standard requirements;
- (b) Programmes for the development of infrastructure relating to metrology, standards, testing and quality.

#### (C) Environment and energy

The activities under this area of focus will promote sustainable industrial development. These activities would include:

- (a) Programmes on environmentally sustainable industrial development strategies and policies;
- (b) Transfer and promotion of technologies and know-how to enhance the efficient use and management of energy, natural resources, and materials to produce less pollution and waste;

- (c) Support programmes involving changes in product design and technology which maximize the reuse and recycling of waste materials;
- (d) Programmes for promoting renewable sources of energy, particularly in remote rural areas;
- (e) Assistance and participation in the implementation of international environmental agreements.

#### **Cross-cutting approaches**

- 6. A number of cross-cutting approaches will characterize the Organization's activities in the identified focus areas:
- (a) Continuous improvement in the managerial and financial performance of the Organization as well as the technical expertise and professional competence of UNIDO personnel;
- (b) Establishment of a balanced portfolio of activities relating to implementation of the environmental agreements and traditional industrial development functions in areas such as investment and technology promotion, small enterprise development and trade capacity-building;
- (c) A proper mix of operational activities and global forum functions involving analysis, dissemination of knowledge and discussions of industrial development issues;
- (d) Creation, transformation and management of knowledge on, and best practices in relevant areas such as industrial development, technology, industrial statistics, skills;
- (e) Promotion of new and emerging technologies;
- (f) Assistance with rehabilitation and reconstruction of industrial infrastructure in countries emerging from crisis situations in cooperation and coordination with other international organizations and within UNIDO's mandate;
- (g) Coordination of UNIDO activities with national policies and priorities as well as nationallyowned poverty reduction strategies;
- (h) Promotion of partnerships with the organizations of the private sector and of civil society;
- (i) Strengthening UNIDO's advocacy function and enhancing its visibility;

(j) Consolidating UNIDO's reform process in order to increase its efficiency to fulfil its mandate.

#### **Regional dimensions**

- 7. There will be a number of regional dimensions to UNIDO's work in the coming years. In this regard, UNIDO will consult with each regional group to define regional strategies as a way to enhance sustainable industrial development.
- 8. Given its unique development problems, Africa, in particular sub-Saharan Africa, will receive special attention in the Organization's technical cooperation and global forum activities.
- 9. Due consideration will be given to the differentiated challenges and opportunities of other regions—Asia and the Pacific, Latin America and the Caribbean and countries with economies in transition.
- 10. Effective decentralization of the Organization's functions and activities to the field will be continued and strengthened through various measures including networking, arrangements with the United Nations Development Programme and other development agencies, whilst ensuring proper evaluation of this process in consultation with Member States.
- 11. Promotion of South-South cooperation will be an important feature of UNIDO's work in the coming years.

#### Finance for development

- 12. UNIDO will strive to mobilize adequate financial resources for its technical assistance and global forum activities and also to increase their levels over the next 10 years. This will be done through:
- (a) Seeking a fair share of the increase in the official development assistance expected in the coming years;
- (b) Negotiating for increased allocations under various multilateral environment agreements, and seeking allocations from new and additional multilateral funds, including taking advantage, within its mandate, of human security funds to finance its industrial development activities;
- (c) Designing other innovative measures including funding from the private sector and industry associations.
- 13. UNIDO will strengthen its policy of promoting public awareness of its activities and reinforce the Goodwill Ambassadors initiative, launched by the Director-General in October 2004, with a view to

mobilizing funds for developing countries, and particularly least developed countries.

14. In this connection, the Organization will continue to refine and streamline its methods of work to more efficiently address the needs and interests of its donor and recipient Member States to achieve the MDGs.

#### UNIDO in the multilateral system

15. UNIDO will continue and enhance its cooperation arrangements with other international, regional and subregional organizations, in the relevant areas of UNIDO activities. At the same time it will strive to contribute to the coherence of the United Nations development system through the adoption of an agreed, MDG-based business plan or common agenda of action on the basis of the concept of issue-based leadership.

## GC.11/Res.5 COOPERATION AGREEMENT WITH THE UNITED NATIONS DEVELOPMENT PROGRAMME

The General Conference,

Recalling that the Business Plan on the Future Role and Functions of UNIDO called for an effective decentralization of activities and strengthened field representation,

Recalling General Conference resolutions GC.10/Res.2 encouraging the Director-General to carry forward the process of decentralization to the field and further strengthen and rationalize the field operations of the Organization, and GC.10/Res.10 requesting the Director-General to present additional recommendations on decentralization following the review of the field operations,

Further recalling the establishment of the informal advisory group on decentralization,

Recalling decision IDB.28/Dec.2, in which the Industrial Development Board recommended that UNIDO's new field presence be expanded in a carefully planned, phased-in approach,

Bearing in mind the conclusions of the report on the assessment of field representation and the options for strengthening and rationalizing the field presence, with the aim of increasing and extending the Organization's technical cooperation delivery, while enhancing its participation in the United Nations system at the country level, as referred to in Board decision IDB.28/Dec.2,

Noting Programme and Budget Committee conclusion 2004/6, which acknowledged the possible benefits of the Agreement with the United Nations Development Programme,

Taking note of the information provided in documents GC.11/7 and Add.1 and GC.11/CRP.7 on the progress within the context of the strategic alliance with the United Nations Development Programme through the Cooperation Agreement signed on 23 September 2004,

Noting the potential importance of this Agreement as an example for inter-agency cooperation in the United Nations system, and recalling the United Nations 2005 World Summit outcome document to further strengthen system-wide coherence between United Nations agencies, funds and programmes, as well as United Nations General Assembly resolution 59/250 on the triennial comprehensive policy review of operational activities for development of the United Nations system,

Also noting the benefits of jointly developing programmes and projects, including in the private sector, under the Agreement,

- 1. Appreciates the efforts of the Director-General in initiating this innovative Agreement and of the Secretariat in carrying forward its implementation;
- 2. Underlines the importance of a costeffective decentralization of UNIDO activities and strengthened field representation, as called for in the Business Plan;
- 3. *Invites* the Director-General to continue his consultations with Member States on the implementation plan of the Agreement;
- 4. *Notes* that the implementation of the Agreement should not negatively impact on existing projects and field structures, during the pilot phase, beyond what has been proposed in decision IDB.28/Dec.2;
- 5. *Requests* the Director-General in consultation with the Administrator of the United Nations Development Programme:
- (a) To continue pursuing the implementation of the Agreement, with the aim of ensuring effective and sustainable decentralization of activities and the expansion of UNIDO's field presence;
- (b) To continue strengthening activities with regard to private sector development, as called for in the Agreement, and to support developing countries in

this area within the context of the United Nations Development Assistance Framework;

- (c) To ensure adequate funding is made available, from within existing resources, to enable the effective decentralization of activities and the expansion of UNIDO's field presence during the pilot phase of the Agreement;
- 6. Requests the Director-General to undertake an assessment of the outcome of the pilot phase in consultation with Member States at the end of the phase and present results and recommendations to the Industrial Development Board at its thirty-second session, with a view to taking appropriate decisions;
- 7. Emphasizes that the evaluation which will follow the pilot phase should assess the impact of the Cooperation Agreement in terms of enhancing and expanding technical cooperation services and providing a cost-effective modality for the expansion of UNIDO's field representation;
- 8. Requests the Director-General to continue to submit regular progress reports to the governing bodies of UNIDO on the implementation of the Agreement.
