Matters related to intergovernmental, non-governmental, governmental and other organizations

Note by the Director-General

Provides information on the status of relations with intergovernmental organizations and international non-governmental organizations including developments since the twelfth session of the General Conference, as well as a review of the subject undertaken by the Secretariat.

Introduction

1. In accordance with Article 19 of the Constitution, the General Conference, at its first session, issued guidelines according to which the Director-General, with the approval of the Industrial Development Board, may enter into agreements or establish appropriate relations with certain organizations (decision GC.1/Dec.41, annex). Paragraphs 4, 11 and 19 of the guidelines stipulate that the Director-General shall report to the Conference at each regular session on any agreements with intergovernmental or governmental organizations or other organizations of the United Nations system entered into by him on behalf of the Organization and on any consultative relations established since the preceding regular session. The present document complies with those stipulations, and provides information on related events that have taken place since the twelfth session of the General Conference.

For reasons of economy, this document has been printed in a limited number. Delegates are kindly requested to bring their copies of documents to meetings.



I. Intergovernmental organizations

2. Since the issuance of document GC.12/10, no new requests for relationship agreements with intergovernmental organizations (IGOs) have been considered by the Board. Thus, the number of IGOs with which the Director-General has been authorized to negotiate such agreements remains at 51 as shown in annex I to the present document.

II. Non-governmental organizations

3. At its thirty-fourth session the Board, in decision IDB.34/Dec.4, decided to grant consultative status to one non-governmental organization (NGO) (Forum Francophone des Affaires).

4. At its thirty-fifth session the Board, in decision IDB.35/Dec.9 decided to grant consultative status to two non-governmental organizations (NGOs) (International Trade Union Confederation and Latin American Organization of Intermediate Governments). Thus, a total of 143 NGOs are currently in consultative status with UNIDO, as shown in annex II to the present document.

III. Review of cooperation status

5. Following suggestions made by some Member States, the Secretariat has undertaken a comprehensive review of the status of cooperation between UNIDO and the various intergovernmental, non-governmental, governmental and other organizations that have concluded a relationship agreement or been granted consultative status with the Organization. In the course of this review, a questionnaire was sent to all IGOs and NGOs listed in the present document in January 2009, with a reminder sent one month later.

6. As a result, out of 51 IGOs, nine replies were received, eight of which expressed interest in cooperating with UNIDO in the next three years. Out of 141 NGOs, 27 returned a completed questionnaire, 22 of which indicated their wish to continue cooperating with UNIDO. Among the 90 NGOs that did not respond to the questionnaire however, 17 have participated in sessions of the governing bodies of UNIDO in the past three years. Additionally, a number of organizations were found to be inactive or could not be traced while some questionnaires were returned undelivered, despite various attempts by the Secretariat (Annexes I and II refer).

IV. Legal background

7. With regard to IGOs there is no specific provision in the guidelines contained in decision GC.1/Dec.41 concerning the termination of a relationship agreement. However, relationship agreements with IGOs usually contain an article giving each party the right to terminate the agreement by notice to the other party.

8. As regards NGOs, decision GC.1/Dec.41, annex B, paragraph 20 (b) foresees that "the Board may in reviewing the list conclude that an organization in

consultative status, which has not shown interest and goodwill in cooperating with UNIDO during a period of three years, may be deemed not to have sufficient interest to warrant the continuance of such a relationship”. It should be noted that in the letter sent to NGOs, the organizations were informed of the above possible consequences.

V. Action required of the Conference

9. The Conference may wish to take note of the information contained in the present document.
