Application from a non-governmental organization for consultative status

Note by the Director-General

The present document provides information on ISEKI-Food¹ Association (IFA), a non-governmental organization applying for consultative status with UNIDO.

1. In accordance with Article 19.1 (b) of the Constitution of UNIDO and the Guidelines for the Relationship of UNIDO with intergovernmental, governmental, non-governmental and other organizations (decision GC.1/Dec.41), in particular paragraph 17 of the annex thereto, information on ISEKI-Food Association (IFA), a non-governmental organization (NGO) seeking consultative status with UNIDO, is circulated to the members of the Board in the annex to the present document. More detailed information on the NGO is available with the Secretariat.

2. Paragraph 17 of the annex to the Guidelines stipulates that the Board shall establish appropriate procedures for reviewing applications from NGOs for consultative status. To facilitate and accelerate its work, the Board may wish to follow the practice established at previous sessions and request the Bureau of the

IFA is aiming to promote a network of universities, research institutions and companies in the food chain, work towards quality assurance of food studies, promote synergies between research, education/teaching and industry, develop a virtual community of experts in the field of food, stimulate the development of common projects and cooperate in the implementation of quality criteria in the food chain.
