## Statement of the Delegation of Ukraine at the 38<sup>th</sup> Session of the Industrial Development Board of UNIDO

(Vienna, 24-26 November 2010)

## Mr. Chairman,

Taking this opportunity I would like to congratulate you, Mr. Chairman, and other members of the Bureau on your election and to wish all delegations gathered today successful deliberations.

On behalf of the Government of Ukraine we would like to positively note the financial performance report for 2008-2009 and the annual report on the activities of the Organization in 2009. We appreciate UNIDO's efforts to improve the management and financial situation of UNIDO as well as to secure the fulfilment of the main priorities of the Organization.
