Report by the Director-General

This addendum updates the information provided in document GC.14/5.

1. Subsequent to the issuance of document GC.14/5 and as announced in information note No. 62, a communication was received on 14 November 2011 from the Permanent Mission of Pakistan that Mr. Muhammad Akhtar Buland Rana had been appointed as the Auditor General of Pakistan. Mr. Rana has therefore replaced Mr. Tanwir Ali Agha, who retired on completion of his term of duty, as the External Auditor of UNIDO and also as candidate for External Auditor of UNIDO.

2. Thus, as of 14 November 2011, the status of candidatures for the appointment of an External Auditor is as follows:
