SUMMARY OF MEETINGS

3rd plenary meeting (morning)

Item 4: Organization of work

Upon the recommendation of the General Committee, the Conference decided:

- a) To cover items 7 to 20 in the form of a general debate;
- b) To establish, in accordance with rule 44 of its rules of procedure, one Main Committee, under the Chairmanship of Mr. Santiago Martínez-Caro (Spain) on which each Member participating in the Conference may be represented;
- c) To refer agenda items 7 to 20 to the Main Committee for more focused debate aimed at the preparation of consensus draft decisions and resolutions for submission to the plenary, and to request the Chairman of the Main Committee to submit a written report on its work in accordance with its decision GC.3/Dec 11 to the Conference at the closing session of the plenary;
- d) That the list of speakers of the general debate would be closed at 12 noon on Wednesday, 30 November 2011;
- e) That draft decisions and resolutions should be submitted to the President of the Conference with a copy to the Chairman of the Main Committee by 12 noon on Wednesday, 30 November 2011.

Item 5: Credentials of representatives to the Conference

The composition of the Credentials Committee is as follows: China, Costa Rica, Denmark, Egypt, Italy, Panama, Republic of Korea, Russian Federation, and Senegal.

General debate – Items 7 to 20 (*continued*)

With the President in the Chair, statements were made by representatives of Islamic Republic of Iran (on behalf of the Group of 77 and China), Poland (on behalf of the European Union), Algeria (on behalf of the African Group), Thailand (on behalf of the Asia and Pacific Group), Sudan, Germany, Russian Federation, France, Saudi Arabia and Ukraine.

Main Committee – 1st meeting

The Chair, Mr. Santiago Martínez-Caro (Spain), opened the first meeting. The Main Committee elected by acclamation the following Vice-Chairs:

 Ms. Oluwatobi Osobukola-Abubu (Nigeria)
 Ms. Hana Kovacova (Slovakia)
 Mr. Satya Rodrigo (Sri Lanka)

The Chair considered the recommendations of the Industrial Development Board, which had also received consensus by the informal consultations in preparation of the fourteenth session of the General Conference. As a result, the Committee adopted seven draft decisions for transmission to the plenary on items 10 (a), 10 (b), 10 (c), 10 (d), 11, 14 and 16. The Committee also adopted two draft decisions on item 10 (b), on the restoration of voting rights for Brazil and a proposed payment plan for Costa Rica, for consideration by the plenary on 30 November 2011. Draft decisions on items 10 (e)

and 20, as well as four resolutions on items 11 and 12, were also adopted for transmission to the plenary.

With the President in the Chair, statements were made by representatives of Japan Lebanon, Costa Rica, Spain, Turkey, Colombia, Kazakhstan, Philippines, Kenya, Republic of Korea, Morocco, Thailand, Pakistan, Norway, South Africa, Mexico, India, Tunisia, Azerbaijan and Cuba.

Main Committee – 2nd meeting

The Committee adopted a draft resolution on the Vienna Ministerial Declaration for the Least Developing Countries, under item 17, for consideration by the plenary.
