## Financial situation of UNIDO

### Report by the Director-General

The present document provides information on the financial situation of the Organization as at 31 March 2012.

## I. Overview

1. The financial situation as at 31 March 2012 can be summarized in the following major points:
  - (a) Regular budget gross expenditure of 23.1 per cent reflects a lower level than that of the similar period in the previous biennium of 26 per cent;
  - (b) The operational budget expenditure amounted to €2.9 million in the reporting period. Support costs and other income amounted to €6.8 million at the end of the first quarter of 2012;
  - (c) The expenditure level for buildings management amounted to €13.5 million in accordance with the prevailing workplan;
  - (d) The level of regular budget cash resources (including the Working Capital Fund) was €77.8 million. In comparison, the cash balance as at 31 March 2011 and 2010 was €55.2 million and €74.7 million, respectively;
  - (e) The collection rate of 2012 assessed contributions at 31 March was 39 per cent, compared to the 2011 and 2010 rates of 26.4 and 52.3 per cent, respectively. The significantly higher collection rate in the year 2010 is due to two major contributors paying their contribution in the first quarter of the year;
  - (f) The collection rate of prior years' arrears, as compared to the current year's assessments, was 14.2 per cent. The rate as at 31 March 2011 and 2010, as compared to the assessments of those years, was 1 per cent.;
  - (g) Outstanding assessed contributions amounted to €146.1 million, as shown in the annex to the present document (including arrears of €69.1 million by the United States of America, and €2.1 million by the former Yugoslavia). The outstanding amounts as at 31 March 2011 and 2010 were €170.1 million and €152.2 million, respectively;
  - (h) The Working Capital Fund was at the level of €7,423,030. However, an amount of €152,067 was outstanding as at 31 March 2012;
  - (i) A conference room paper will be provided on the status of assessed contributions and voting rights, updated to 31 May 2012.

## II. Regular and operational budgets, 2012-2013

### A. Regular budget

2. The implementation of the biennial regular budget commenced with the establishment of an initial release threshold by budget line and/or major object of expenditure to facilitate sufficient funding at the commencement of the biennium and to ensure a smooth run of activities for each required budget category.
3. Therefore, allotments to the value of €70.1 million were issued at the onset of the biennium. These comprised of €42.7 million for staff in established posts and €27.4 million for all other expenditure categories. Further reductions in allotments in the amount of €0.4 million were made in the first quarter.

4. As at 31 March 2012, regular budget expenditures totalled €17.9 million, which represents 23.1 per cent of the gross expenditure budget for 2012. These indicators are comparable with those of the previous biennium where at 31 March 2010, the regular budget expenditure amounted to €20.7 million with a 26.0 per cent utilization rate of the gross expenditure budget.

## B. Operational budget

5. Allotments of €12.8 million were issued at the start of 2012. This level is equivalent to 100 per cent of estimates included in the approved programme and budgets for all budget categories except staff costs, where the released allotments were calculated on the basis of staff on board at the commencement of the current biennium. Further allotments in the amount of €0.8 million were issued in the first quarter.

6. Operational budget expenditures amounted to €2.9 million on 31 March 2012. In the preceding biennium expenditures amounted to €2.1 million in the similar reporting period.

7. The technical cooperation activities in the first quarter of 2012 reached US\$ 81.4 million, including obligations. The income from support costs and other miscellaneous sources for this period amounted to €6.8 million.

## C. Buildings management

8. The buildings management budget is being implemented in accordance with the prevailing workplan.

9. An allotment of €30.2 million was issued for 2012 at the start of the biennium.

10. Expenditures as at 31 March 2012 amounted to €13.5 million compared to €11.4 million in the similar period in the previous biennium. This rate represents 42.6 per cent of the buildings management gross expenditure budget and is indicative of the fact that a greater portion of utilities and the rental and maintenance obligations of premises are routinely expended in the first quarter of the year.

# III. Assessed contributions

## A. Collections

11. A total of 42 Member States, including eight least developed countries (LDCs), have made full payments. Sixty-nine Member States, eleven of which are LDCs, have made partial payments and/or their adjustments have been credited towards their assessed contributions for the year 2012. The collections in the period from January to March 2012, broken down by List of States, are shown in table 1.

## B. Outstanding contributions

12. The detailed status of assessed contributions outstanding as at 31 March 2012 is contained in the annex to the present document. The scale of assessments and outstanding contributions as of the same period, broken down by List of States, are shown in table 2.

## IV. Voting rights

13. As indicated in the annex to the present document, the voting rights of 39 Member States had been suspended as at 31 March 2012, in accordance with Article 5.2 of the Constitution and financial regulation 5.5 (b). In comparison, the voting rights of the same number of countries (39) had been suspended at the same time last year. The status of voting rights in respect of the various policymaking organs is shown in table 3.

14. In order to restore their voting rights for 2012, these Member States must pay their full contributions for 2009 and prior years, including advances to the Working Capital Fund, as well as a partial contribution for 2010. The minimum total amount that would have to be paid by these Member States is €9,683,370.

## V. Multi-year payment plans

15. Table 4 shows, in summary form, the current status of those Member States that have entered into payment plan arrangements to settle outstanding assessed contributions. The Secretariat notes with appreciation and recognizes the considerable efforts made by all those Member States that have honoured their commitments and obligations as stipulated in their respective payment plans. Other Member States in arrears are encouraged to consider submitting payment plans to steadily reduce their outstanding assessed contributions. Azerbaijan has successfully completed a 10-year payment plan.

## VI. Arrears by former Member States

16. The amount of arrears owed to UNIDO by the United States of America is €69,068,887 (1994-1996), while the arrears of the former Yugoslavia amount to €2,081,599 (1990-2001). Payment of these arrears is being pursued by the Secretariat.

## **VII. Unutilized balances of appropriations and interest income in excess of budgetary estimates**

17. Information on the unutilized balances of appropriations was provided in document GC.14/18. Further information on the amounts of unutilized balances of appropriations that were renounced by Member States and how these funds are being used to strengthen UNIDO programmes will be provided in document IDB.40/8-PBC.28/8.

## **VIII. Action required of the Committee**

18. The Committee may wish to consider recommending to the Board the adoption of the following draft decision:

“The Industrial Development Board:

“(a) Takes note of the information provided in document IDB.40/4-PBC.28/4;

“(b) Urges those Member States and former Member States that have not yet paid their assessed contributions, including advances to the Working Capital Fund and prior years’ arrears, to do so without delay;

“(c) Requests the Director-General to pursue his efforts and contacts with Member States and former Member States to effect the collection of arrears.”
