SUMMARY OF MEETINGS

1st PLENARY MEETING

Item 1: Opening of the fifteenth session

The Conference was opened by H.E. Mr. Ramiro González, Minister of Industries and Productivity (Ecuador), who made a statement.

The Conference observed a minute of silence dedicated to prayer or meditation.
