Current global economic and social challenges such as the rising youth unemployment, the financial crisis, increased levels of poverty and climate change coupled with the inability to fully realise the MDGs make it even more compelling that we collectively address how we can collaborate and inject greater impetus towards a new revolution for inclusive and sustanable development. The attainment of the necessary socio-economic transformation that we all seek within the context of the post-2015 development agenda, can only be predicated on making industrial development a priority. Thus the theme of this conference, "UNIDO: Towards partnerships for a new industrial revolution for inclusive and sustainable growth", is apt as it underscores the importance of social, economic and environmental dimensions of sustainable development as well as social inclusion. The theme embodies the necessary prerequisites such as public private partnerships, job creation, economic diversification, equitable social conditions, women and youth empowerment, entrepreneurship and poverty alleviation.
