## Financial situation of UNIDO

### Report by the Director General

The present document provides information on the financial situation of the Organization as at 31 March 2014.

## I. Overview

1. UNIDO's financial situation as at 31 March 2014 can be summarized in the following major points:
  - (a) Regular budget gross expenditure spending-rate of 25.8 per cent reflects a slightly higher level than that of the same period in the previous biennium of 23.1 per cent;
  - (b) The operational budget expenditures amounted to €3.8 million in the reporting period. Support costs income amounted to €3.4 million in three months of 2014;
  - (c) The expenditure level for buildings management amounted to €10.7 million in accordance with the prevailing workplan;
  - (d) The collection rate of 2014 assessed contributions at 31 March was 36.8 per cent, compared to the 2013 and 2012 rates of 38 and 39 per cent, respectively;
  - (e) The collection rate of prior years' arrears was 1.2 per cent. The rate as at 31 March 2013 and 2012, as compared to the assessments of those years, was 10.2 and 14.2 per cent, respectively;
  - (f) Outstanding assessed contributions amounted to €138.2 million, as shown in the annex to the present document (including arrears of €69.1 million by the United States of America, and €2.1 million by the former Yugoslavia). The outstanding amounts as at 31 March 2013 and 2012 were €138.9 million and €146.1 million, respectively;
  - (g) The Working Capital Fund was at the level of €7,423,030. €403,769 was outstanding as at 31 March 2014;
  - (h) A conference room paper will be issued on the status of assessed contributions and voting rights, with information updated as of 15 June 2014.

## II. Regular and operational budgets, 2014-2015

### A. Regular budget

2. The implementation of the biennial regular budget commenced with the establishment of an initial release threshold by budgetline and/or major object of expenditure to facilitate sufficient funding at the commencement of the biennium and to facilitate activities for each required budget category.
3. Therefore, allotments to the value of €67.7 million were issued at the onset of the biennium. These were comprised of €41.3 million for staff in established posts and €26.4 million for all other expenditure categories.
4. As at 31 March 2014, regular budget expenditures totalled €18.7 million, which represents 25.8 per cent of the gross expenditure budget for 2014. These indicators are comparable with those of the previous biennium where at

31 March 2012, the regular budget expenditure amounted to €17.9 million with a 23.1 per cent utilization rate of the gross expenditure budget.

## B. Operational budget

5. Allotments of €17.3 million were issued at the start of 2014. This level is equivalent to 100 per cent of estimates included in the approved programme and budgets.

6. Operational budget expenditures amounted to €3.8 million on 31 March 2014. In the preceding biennium expenditures amounted to €2.9 million as at 31 March 2012.

7. Technical cooperation activities in the first quarter of 2014 reached \$57.8 million, including commitments. Income from support costs for this period amounted to €3.4 million.

## C. Buildings management

8. Allotments of €28.2 million were issued for 2014 at the start of the biennium.

9. Expenditures as at 31 March 2014 amounted to €10.7 million, compared to €13.5 million in 2012. The expenditure level in the current biennium represents 37.5 per cent of the buildings management gross expenditure budget.

# III. Assessed contributions

## A. Collections

10. A total of thirty-six Member States, including eight least developed countries (LDCs), have made full payments. Fifty-four Member States, eight of which are LDCs, have made partial payments and/or adjustments have been credited towards their assessed contributions for the year 2014. The collections in the period from January to March 2014, broken down by List of States, are shown in table 1.

## B. Outstanding contributions

11. The detailed status of assessed contributions outstanding as at 31 March 2014 is contained in the annex to the present document. The scale of assessments and outstanding contributions as of the same period, broken down by List of States, are shown in table 2.

## IV. Voting rights

12. As indicated in the annex to the present document, voting rights of 42 Member States had been suspended as at 31 March 2014, in accordance with Article 5.2 of the Constitution and financial regulation 5.5 (b). In comparison, the voting rights of 37 countries had been suspended at the same time last year. The status of voting rights in respect of the various policymaking organs is shown in table 3.

13. In order to restore their voting rights for 2014, these Member States must pay their full contributions for 2011 and prior years, including advances to the Working Capital Fund, as well as a partial contribution for 2012. The minimum total amount that would have to be paid by these Member States is €6,244,070.

## V. Multi-year payment plans

14. Table 4 shows, in summary form, the current status of those Member States that have entered into payment plan arrangements to settle outstanding assessed contributions. The Secretariat notes with appreciation and recognizes the considerable efforts made by all those Member States that have honoured their commitments and obligations as stipulated in their respective payment plans. Other Member States in arrears are encouraged to consider submitting payment plans to steadily reduce their outstanding assessed contributions.

## VI. Arrears by former Member States

15. The amount of arrears owed to UNIDO by the United States of America is €69,068,887 (1994-1996), while the arrears of the former Yugoslavia amount to €2,081,599 (1990-2001).

## VII. Unutilized balances of appropriations

16. Through the implementation of General Conference decision GC.15/Dec.13, unutilized balances of appropriations, a total amount of €4,032,511 became available for the purposes specified in the decision. Altogether 21 Member States voluntarily renounced their share of the unutilized balances. Out of the total amount, €942,896 was made available for the special account to retain office space for the biennium 2014-2015 and €3,089,134 was made available for the purpose of strengthening the programmes of UNIDO. The following table provides detailed information on the amounts of renounced unutilized balances.

## VIII. Action required of the Committee

17. The Committee may wish to consider recommending to the Board the adoption of the following draft decision:

“The Industrial Development Board:

- (a) Takes note of the information provided in document IDB.42/4-PBC.30/4;
- (b) Urges those Member States and former Member States that have not yet paid their assessed contributions, including advances to the Working Capital Fund and prior years’ arrears, to do so without delay;
- (c) Requests the Director General to pursue his efforts and contacts with Member States and former Member States to effect the collection of arrears.”
