Lists of States included in Annex I to the Constitution of UNIDO

Note by the Secretariat

- 1. Reference is made to the Lists of States included by the Depositary in Annex I to the Constitution of UNIDO, contained in document UNIDO/GC.1/3. According to Annex I to the Constitution, the Lists of States to be included by the Depositary (Secretary-General of the United Nations) in that Annex are the lists determined by the General Assembly of the United Nations for the purpose of section II, paragraph 4, of General Assembly resolution 2152 (XXI), as in effect on the date the Constitution entered into force, namely on 21 June 1985.
- 2. As of 16 March 2015, 170 States were Members of UNIDO. Of these, 169 are shown in the Lists of States to be included by the Depositary in Annex I to the Constitution (see overleaf). The following Member State is not yet included in any of those lists:


Marshall Islands 16 March 2015
