# Application from non-governmental organizations for consultative status

# **Note by the Director General**


The present document provides information on the World Federation of Engineering Organizations (WFEO), a non-governmental organization applying for consultative status with UNIDO.

1. In accordance with Article 19.1 (b) of the Constitution of UNIDO and the Guidelines for the Relationship of UNIDO with intergovernmental, governmental, non-governmental and other organizations (decision GC.1/Dec.41), in particular paragraph 17 of the annex thereto, information on the World Federation of Engineering Organizations (WFEO), a non-governmental organization (NGO) seeking consultative status with UNIDO, is circulated to the members of the Board in the annex to the present document. More detailed information on the NGO is available with the Secretariat. WFEO was in consultative status with UNIDO from 1986 to 2011. It was among the 73 NGOs whose consultative status was discontinued upon the adoption of Board decision IDB.39/Dec.11. In February 2015, WFEO expressed interest in reapplying for consultative status.

For reasons of economy, this document has been printed in a limited number. Delegates are kindly requested to bring their copies of documents to meetings.

To facilitate and accelerate its work, the Board may wish to follow the practice established at previous sessions and request the Bureau of the Board to review the application of, and information on, the NGO referred to in the annex to the present document and to submit its recommendations to the Board for consideration at its current session.

## Historical background

WFEO was established in 1968 under the auspices of UNESCO to contribute with engineering expertise and sound, evidence-based solutions, to ensure access to among others sustainable, safe drinking water, energy, waste management, and food. It provides advice and guidance to governments and policymakers on what can be scientifically and technologically achieved based on existing knowledge and technological tools, including those being developed with potential success.
