

## **SUMMARY OF MEETINGS Wednesday, 2 December 2015**

#### 5th PLENARY MEETING

#### General debate Items 7 to 23 (continued)

With the President in the Chair, statements were made by representatives of Chile (on behalf of the Group of 77 and China); Qatar; Japan; Germany; Philippines; Republic of Korea; Tunisia; Chile; Italy; Turkey; Jordan; Costa Rica; South Africa; India; Armenia; Hungary; Tajikistan; Poland; Switzerland; Kenya; and El Salvador.

#### Youth and women entrepreneurship

A side event entitled "Youth and women entrepreneurship" took place during the lunch break. It featured entrepreneurs who had directly benefited from UNIDO programmes: Ms. Sinda Soussaia from Tunisia; Mr. Julius Mugisha from Rwanda; Mr. Melvin Archbold from Nicaragua; Ms. Maw Maw Aung from Myanmar; Ms. Yordanos Goushe Girmay from Ethiopia; and Ms. Luiza Nalbandyan from Armenia. This was followed by a discussion by a panel consisting of: Ms. Ellen Pratt, Deputy Minister for Industry of Liberia; Mr. Raimund Magis, Deputy Director, Multilateral Development Cooperation, Federal Ministry for Europe, Integration and Foreign Affairs of Austria; Ms. Delphine Borione, Deputy Secretary General of the Union for the Mediterranean; Mr. Mohammad Naciri, Regional Director for Arab States Region of UNWOMEN; and Ms. Janne Vangen Solheim, Chief Executive Officer Janusfabrikken AS of Norway and newly appointed UNIDO Goodwill Ambassador. The moderator of the event was Ms. Selma Prodanovic, speaker, entrepreneur, philanthropist, and advisor.

#### Transparency Initiative: Launch of the Open Data Platform for all programmes and projects at a glance

As part of the Transparency Initiative, the new Open Data Platform, which presents all programmes and projects at a glance, will be available to external stakeholders as of 30 November 2015. The Platform displays an interactive world map with details of ongoing programmes and projects – including outcomes and outputs, timelines, financial information, gender equality information, project documents as well as country statistics, donor information and more.

The Open Data Platform has been designed to display data directly from the enterprise resource planning (ERP) system and is updated on a regular basis. It serves as a central user-friendly access point to enable better monitoring and reporting for all stakeholders.

The Platform has already been demonstrated to the Member States and donors at previous occasions and tested by the Transparency Initiative Liaison Group of Member States prior to its launch. In 2016, UNIDO will continue to extend and improve the scope, quantity, and quality of the information available.

Delegates are invited to visit the two exhibition areas located on the first and second floors in M01 and M02 to receive live demonstrations and learn more about UNIDO's Transparency Initiative.
