

I. Introduction

1. The Joint Inspection Unit (JIU) became a subsidiary organ of the Industrial Development Board by its decision IDB.1/Dec.22. A system of follow-up to JIU recommendations was outlined in document IDB.24/18 and subsequently approved in decision IDB.24/Dec.11. In accordance with the provisions therein, JIU reports will be considered by each regular Board session.

II. Reports and notes submitted by the Joint Inspection Unit

2. A total of thirteen JIU reports¹ and one management letter were received² by the Organization since the previous Board document covering this subject (IDB.43/9). Ten reports and one management letter as listed below are of relevance to UNIDO:³

JIU/REP/2014/6: Analysis of the evaluation function in the United Nations system

JIU/REP/2014/8: Use of non-staff personnel and related contractual modalities in the United Nations system organizations — country case studies: Democratic Republic of the Congo, Haiti and India

A further three reports issued by JIU were not of relevance to UNIDO:

JIU/REP/2016/1 — Review of management and administration in the International Telecommunication Union (ITU).

3. In line with recommendations from the JIU's management letter (JIU/ML/2016/15) to UNIDO relating to reports to the Industrial Development Board, the present document has been changed to include hyperlinks to the JIU reports as well as hyperlinks to the relevant CEB comments on said reports. It is recalled that recommendations and statistics applicable to UNIDO, as well as UNIDO's compliance and comments on recommendations are available through the web-based tracking system (WBTS).⁴ A summary of UNIDO comments on the reports is included in the annex to the present document.

4. The reports contain a total of 67 recommendations relevant to UNIDO. UNIDO accepted and complies with 55 of these, seven were not accepted, and five are under consideration.

III. Implementation of Joint Inspection Unit recommendations at UNIDO

5. Since the Unit enhanced its follow-up system through the WBTS, which is available at the JIU website, Member States can be granted "read-only" access to yearly consolidated data on the status of implementation of recommendations by registering with the JIU through the Focal Point for JIU matters in UNIDO, the Office of Internal Oversight and Ethics.⁵

6. In the last quarter of each year, the JIU requests from UNIDO, pertinent information on recommendations issued in the last three years, i.e. status of acceptance (accepted, rejected, under consideration), status of implementation (not started, in progress, implemented) and impact. The JIU then presents the aggregate outcome in its yearly activity report to the United Nations General Assembly.

7. The status of acceptance and implementation for UNIDO for the period 2013-2015 is presented in the table below (in percentage of recommendations issued).

8. It should be noted that UNIDO remained one of the organizations showing a consistently strong performance regarding the status of acceptance (85 per cent and above) with regard to the status of considerations of reports by its governing bodies.

IV. Work programme 2016

9. In accordance with United Nations General Assembly resolution 61/260 of 4 April 2007, by which the Assembly decided to consider jointly the annual report and programme of work of JIU during the first part of its resumed session, the Unit launched the preparation of its programme of work for 2016 in July 2015.

10. The Unit invited participating organizations to submit their proposals, and JIU considered a shortlist of 15 topics, resulting from consultations with participating organizations and internal consultations, as well as 16 topics from the 2016-2017 roster.

11. The programme of work for 2016 includes seven new projects, five of which are of system-wide or multiple-organization coverage and two relate to management and administrative review of a participating organization. UNIDO is one of the organizations JIU has included for a management and administrative review. Member States were informed of the review with an information note on 15 March 2016. The JIU's work plan also includes 11 projects carried forward from the previous workplan.

12. Of the seven topics on the 2016 work programme, the below six would be of interest to UNIDO:

(a) Review of administrative services delivery in selected United Nations system organizations;

(b) Review of knowledge management in the United Nations system;

(c) Donor-led accountability and oversight review in United Nations system organizations;

(d) Comprehensive review of United Nations system support for small island developing States: final findings;

- (e) Review of travel policies in the United Nations system;
- (f) Review of management and administration in UNIDO.

13. UNIDO continues to note with appreciation the close cooperation between JIU and the Secretariat of the United Nations System Chief Executives Board for Coordination (CEB).

V. Action required of the Board

14. In compliance with the provisions of the Statute of JIU Article 11(4), resolution 48/221 of 23 December 1993 of the United Nations General Assembly, and paragraph 9 of the system of UNIDO follow-up to JIU recommendations, the Board may wish to take note of the information contained in the present document and provide guidance for further concrete action.

The one recommendation not supported relates to include long-serving non-staff to apply as internal candidates for vacant positions; UNIDO feels that this may be prejudicial to the interests of other external candidates. The recommendation relating to ensuring that proportionate fraud and prevention capabilities are an integral part of the ERPs was not accepted. UNIDO considers that the recommendation is desirable but fails to account for the high cost (and related go-live risks) of revising the existing functionalities and integrating potential improvements to the ERP system already in place.
