

2 Sustainable supply chain through SSTIC

As a key axis of international cooperation, SSTIC bridges global value chains and sustainability. This publication highlights SSTIC's role in fostering economic resilience, environmental stewardship, and social inclusion through sustainable supply chain development. It covers three main areas: Sustainability Standards, focusing on norms and benchmarks for sustainable operations; Skills Development, building technical capabilities for supply chain management; and Value Chain Development, detailing efforts in industrial diversification and value addition for economic growth and competitiveness.







3 Ending Hunger through SSTIC





As the global community grapples with the persistent challenge of hunger, SSTIC offers a dynamic platform for innovative solutions and coordinated action. SSTIC leverages industrial cooperation and shared experiences to combat hunger by promoting the transfer and adaptation of advanced agricultural technologies like precision farming and modern storage methods and encouraging best practices for productivity and food security. This publication explores UNIDO's approach through four key domains: Agribusiness Development, demonstrating SSTIC's role in technology transfer and agricultural practices; Food Security and Food Safety, focusing on policy advice and market access for farmers; Agro-Industrial Parks, highlighting efforts in diversification and rural entrepreneurship; and Bioeconomy, showcasing value addition in agricultural products to create opportunities and strengthen food systems.

4 Event Summary – UNIDO's South-South Investment Forum

The South-South Investment Forum, organized by UNIDO in collaboration with Afreximbank and China Eximbank, highlighted the transformative potential of South-South investments. Held on November 10, 2023, in Cairo, the forum showcased the rapid growth of South-South trade, now surpassing North-South trade-in value. Critical discussions focused on identifying investment opportunities, de-risking, financing frameworks, and catalysts for investment. The event emphasized leveraging the African Continental Free Trade Area (AfCFTA) and presented actionable solutions for overcoming resource constraints and technological gaps. Keynote speakers underscored the importance of strategic collaboration and innovation for sustainable global growth. This event summary provides an overview of the objectives, constructive discussions and take aways from the forum.

South-South and Triangular Cooperation (2021) by UNIDO

This 2021 UNIDO brochure presents the organization's SSTIC initiatives. Covering 20 projects along four thematic priorities, it explains how UNIDO employs SSTIC to advance inclusive and sustainable industrial development (ISID) and support the Sustainable Development Goals (SDGs).

The document outlines UNIDO's SSTIC framework and services, along with development frameworks like the Programme for Country Partnership (PCP) and Third Industrial Development Decade for Africa (IDDA III). It provides case studies of SSTIC projects across various sectors and regions, focusing on shared prosperity, economic competitiveness, environmental protection, and strengthening knowledge and institutions. It also introduces tools developed by UNIDO, like the International Guidelines for Industrial Parks, to promote best practices in industrial development.

Key themes addressed include women's economic empowerment, sustainable energy, and industrial park

development. Throughout, the document emphasizes knowledge sharing, technology transfer, and capacity building between Southern countries.

The brochure serves as both a record of UNIDO's SSTIC achievements and a guide for future cooperation in industrial development among developing countries. It showcases successful projects and approaches that can be replicated and scaled up across the Global South to promote ISID and achieve the SDGs.

Case study Bhutan - Green electric solutions for urban transport

Thimphu, Bhutan is a city on the verge of a transportation revolution. Supported by UNIDO and Austria's Federal Ministry for European and International Affairs, Thimphu is introducing electric buses and building green infrastructure. This innovative project, guided by South-South and Triangular Industrial cooperation with technology from China and expertise from Austria and New Zealand, aims to replace fossil fuels with clean energy, paving the way for a sustainable transport future in Bhutan.









Case study Ethiopia - Leather Initiative for Sustainable Employment Creation







Ethiopia, Africa's leader in livestock and leather production. faces challenges like unemployment and environmental issues. UNIDO's EU-funded Leather Initiative for Sustainable Employment Creation (LISEC) aims to transform Oromia's leather sector through South-South and triangular cooperation. By developing Modjo Leather City (MLC), the project provides training, materials. and environmental access protections, creating jobs and setting a model for a sustainable leather industry in Ethiopia.

Case Study Ethiopia - Upgrading Livestock Value Chain





Ethiopia, with one of Africa's fastest-growing economies, relies heavily on its livestock sector, crucial for GDP and rural livelihoods. Despite its potential, the sector faces challenges like inadequate infrastructure, market access issues, and environmental concerns. UNIDO, partnering with China, is addressing these through South-South and triangular cooperation, aiming to boost exports, enhance value chains, attract investments, and ensure sustainability. This initiative empowers women and youth, promotes eco-friendly practices, and fosters a resilient livestock industry, setting a model for other developing countries.



SSTIC Case Study Iran – Emergency response assistance to COVID

As COVID-19 spread globally, Iran faced a surge in medical waste, straining its limited disposal capacity. In response, UNIDO, in collaboration with China and Iran, launched an emergency project to ensure safe and eco-friendly medical waste disposal. The project provided essential equipment and training to hospital staff and government agencies. It aimed to strengthen Iran's waste management capabilities and promote sustainable practices. This initiative highlights the power of South-South cooperation in addressing emergencies and showcases UNIDO's commitment to innovation and inclusive development.









SSTIC Case Study Latin America – E-waste management







E-Waste is a growing threat in Latin America, with only 3% collected responsibly. To address this, 13 countries collaborated to establish a regional e-waste monitor, assessing volume, legislation, infrastructure. Funded bv GEF implemented by UNIDO, this project empowers national initiatives through South-South and triangular industrial cooperation. It promotes knowledge sharing and capacity building to tackle e-waste. This initiative highlights South-South cooperation's power in addressing environmental challenges and showcases UNIDO's commitment to innovation and inclusive development.



SSTIC Case Study Southeast Asia – Support to cope with climate change.

Southeast Asia faces rising energy demand and climate challenges. UNIDO launched a program with Malaysia, Thailand, and Korea to address these issues through South-South and triangular industrial cooperation. Supported by Korea and the Korea Energy Agency (KEA), the initiative promotes renewable energy and efficiency, leveraging Korea's expertise in hydrogen, electric vehicles, and carbon neutrality. Collaboration with the private sector is key. The program also promotes gender equality and women's empowerment. This effort highlights UNIDO's commitment to innovation and sustainable growth in Southeast Asia.









SSTIC Case Study Venezuela – Industrial Upgrading and Modernization Programme





Venezuela, with significant agricultural potential, relies heavily on food imports, producing only 30% domestically. UNIDO, via South-South triangular industrial cooperation, launched the Industrial Upgrading and Modernization Program, focusing on maize, beans, soybeans, rice, and sugar cane value chains to boost food security and economic growth. Collaborating with Food and Agriculture Organization (FAO), International Maize and Wheat Improvement Center (CIMMYT), and Latin American Fund for Irrigated Rice (FLAR), the project modernizes farming, showing a 29% corn yield increase. Leveraging Brazilian expertise, it promotes sustainable production. This initiative enhances local capacity and showcases UNIDO's commitment to sustainable development.
